An Official Race is a race, including Harness Race, of thoroughbred, quarter, Appaloosa, Arabian or other like horses or mules. A training day includes the exercising of horses in preparation to participate in a same-day sanctioned race, that takes place at the Race Track Facility, of the Policyholder.
- The Covered Person must be: 1) a licensed Jockey or Harness Driver insured under the policy; and 2) participating in a Covered Event organized by or sponsored by an Eligible Racing Association while at a Race Track Facility only. Benefits are subject to the Policy Terms and Conditions.
